#### **Catastrophic Coverage Stage**

After your yearly out-of-pocket drug costs reach \$2,000, you pay \$0 for all covered prescription drugs for the remainder of the year.

If you reside in a long-term care facility, your cost-sharing for a one-month supply is the same as at a retail pharmacy for a one-month supply. You may get drugs from an out-of-network pharmacy, but may pay more than you pay at an in-network pharmacy. Some medications (e.g., Specialty medications) are available up to a one-month supply. You won't pay more than \$35 for a one-month supply of each insulin product covered by our plan, no matter what costsharing tier it's on, even if you haven't paid your deductible. During the Catastrophic Coverage Stage, you pay \$0 for all covered insulin products.

Most adult Part D vaccines, including shingles, tetanus and travel vaccines, are covered by our plan at no cost to you across all Part D benefit stages, even if you haven't paid your deductible. Refer to your plan's "Drug List" (Formulary) or contact Member Services for coverage and cost-sharing details about specific vaccines.

Some of our network pharmacies have preferred cost-sharing. You may pay less for certain drugs if you use these pharmacies. Your cost-sharing may vary depending on the pharmacy you choose (e.g., Preferred Retail, Standard Retail, Preferred Mail-Order, Standard Mail-Order, Long Term Care (LTC), Home infusion, etc.) or whether you receive a one-month or a three-month supply or when you enter another phase of the Part D benefit or if you receive "Extra Help." If you reside in a long term care facility, your cost-sharing for a 31-day supply is the same as at a standard retail pharmacy for a 30-day supply. - □ Except in emergency or urgent situations, we do not cover services by out-of-network providers (doctors who are not listed in the provider directory).
- □ This plan is a chronic condition special needs plan (C-SNP). Your ability to enroll will be based on verification that you have a qualifying specific severe or disabling chronic condition.
